



How to Access and Print Your Form I-94, Arrival/Departure Record

If you were recently processed as an undocumented non-citizen or traveler with an alien registration number (A number), follow these instructions to print your I-94 Form from this website. If someone requests your admission information, you need to provide your printed I-94 Form. Follow these steps to print your I-94 Form.
